<b>Friday, February 10, 2017</b>	<b>February monthly activities report</b>  (all lobbyists filing monthly)	January 1, 2017	January 31, 2017
<b>Friday, March 10, 2017</b>	<b>March monthly activities report</b>  (all lobbyists filing monthly)	February 1, 2017, <i>or</i>  January 1, 2017, if first activities report*	February 28, 2017
<b>Monday, April 10, 2017</b>	<b>April monthly activities report</b>  (all lobbyists filing monthly)	March 1, 2017, <i>or</i>  January 1, 2017, if first activities report*	March 31, 2017
<b>Wednesday, May 10, 2017</b>	<b>May monthly activities report</b>  (all lobbyists filing monthly)	April 1, 2017, <i>or</i>  January 1, 2017, if first activities report*	April 30, 2017
<b>Monday, June 12, 2017</b>  <i>Deadline is extended because of weekend.</i>	<b>June monthly activities report</b>  (all lobbyists filing monthly)	May 1, 2017, <i>or</i>  January 1, 2017, if first activities report*	May 31, 2017

\* If you file your initial lobby registration after January 1, 2017, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on March 4, 2017, that registrant's first monthly report (due by April 10, 2017) would cover the period beginning January 1, 2017, and ending March 31, 2017. ***Electronic reports must be filed by midnight, Central Time Zone, on the night of the filing deadline.***

If you are ever confused about the beginning date for a required report, remember this rule for reporting: **There should never be gaps between reporting periods and there should never be overlaps.**

<b>Monday, September 11, 2017</b>  <i>Deadline is extended because of weekend.</i>	<b>September monthly activities report</b>  (all lobbyists filing monthly)	August 1, 2017, <i>or</i>  January 1, 2017, if first activities report*	August 31, 2017
<b>Tuesday, October 10, 2017</b>	<b>October monthly activities report</b>  (all lobbyists filing monthly)	September 1, 2017, <i>or</i>  January 1, 2017, if first activities report*	September 30, 2017
<b>Monday, November 13, 2017</b>  <i>Deadline is extended because of holiday and weekend</i>	<b>November monthly activities report</b>  (all lobbyists filing monthly)	October 1, 2017, <i>or</i>  January 1, 2017, if first activities report*	October 31, 2017
<b>Monday, December 11, 2017</b>  <i>Deadline is extended because of weekend.</i>	<b>December monthly activities report</b>  (all lobbyists filing monthly)	November 1, 2017, <i>or</i>  January 1, 2017, if first activities report*	November 30, 2017
<b>Wednesday, January 10, 2018</b>	<b>January monthly activities report</b>  (all lobbyists filing monthly)	December 1, 2017, <i>or</i>  January 1, 2017, if first activities report*	December 31, 2017
<b>Wednesday, January 10, 2018</b>	<b>Annual activities report</b>  (all lobbyists filing under the modified reporting schedule who were registered in 2017)	January 1, 2017	December 31, 2017

\* If you file your initial lobby registration after January 1, 2017, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on March 4, 2017, that registrant's first monthly report (due by April 10, 2017) would cover the period beginning January 1, 2017, and ending March 31, 2017. ***Electronic reports must be filed by midnight, Central Time Zone, on the night of the filing deadline.***
