Monday, February 11, 2019 <i>Deadline is extended because of weekend.</i>	February monthly activities report (all lobbyists filing monthly)	January 1, 2019	January 31, 2019
Monday, March 11, 2019 <i>Deadline is extended because of weekend.</i>	March monthly activities report (all lobbyists filing monthly)	February 1, 2019, <i>or</i> January 1, 2019, if first activities report*	February 28, 2019
Wednesday, April 10, 2019	April monthly activities report (all lobbyists filing monthly)	March 1, 2019, <i>or</i> January 1, 2019, if first activities report*	March 31, 2019
Friday, May 10, 2019	May monthly activities report (all lobbyists filing monthly)	April 1, 2019, <i>or</i> January 1, 2019, if first activities report*	April 30, 2019
Monday, June 10, 2019	June monthly activities report (all lobbyists filing monthly)	May 1, 2019, <i>or</i> January 1, 2019, if first activities report*	May 31, 2019

* If you file your initial lobby registration after January 1, 2019, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on March 4, 2019, that registrant's first monthly report (due by April 10, 2019) would cover the period beginning January 1, 2019, and ending March 31, 2019. ***Electronic reports must be filed by midnight, Central Time Zone, on the night of the filing deadline.***

If you are ever confused about the beginning date for a required report, remember this rule for reporting: **There should never be gaps between reporting periods and there should never be overlaps.**

* If you file your initial lobby registration after January 1, 2019, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on March 4, 2019, that registrant's first monthly report (due by April 10, 2019) would cover the period beginning January 1, 2019, and ending March 31, 2019. ***Electronic reports must be filed by midnight, Central Time Zone, on the night of the filing deadline.***

If you are ever confused about the beginning date for a required report, remember this rule for reporting: **There should never be gaps between reporting periods and there should never be overlaps.**
